### Important Rules

- This study plan is designed for students taking part in the Double Degree Program in Global Management and Chinese Politics with the Renmin University of China (RUC) and spending the academic year 2025/2026 at RUC. The list of courses to be taken abroad may be subject to changes should the academic offer at RUC be amended.
- Interested students are required to read and understand this study plan and its rules. These are to be considered binding to the successful completion of the double degree program. Changes to the study plan are usually not possible and any request in this sense must be conveyed to the International Development Office, that cannot guarantee its feasibility.
- The listed courses must be taken and passed in the academic year indicated in the scheme (not after). Any possible change must be formally authorized by the Academic Commission.
- During the mobility, students will be subject to the rules of RUC.
- At the end of the program, if compliant with both Luiss and RUC academic requirements, students will obtain both the Master in Law majoring in International Studies (issued by RUC) and the Master's Degree in Global Management and Politics (issued by Luiss).
- Please note that students will obtain RUC's degree in June 2027, even though they can in some cases finish all the required activities earlier.

#### Thesis

- Students will complete their theses according to the timeline below with one supervisor from RUC and one supervisor and an external reader or co-supervisor from Luiss.
- Students must respect the thesis procedures and deadlines from both institutions. Each institution will grade the final thesis according to its own standards.
- Students will be assigned a supervisor from RUC, while students are required to contact and agree on a Luiss supervisor autonomously in due time.
- Students must seek supervisors' approval of the proposal and all intermediate and final steps of the thesis, which must meet Luiss and RUC standards.
- Students will have two options to complete the thesis requirements for RUC and Luiss:
  - Option A (one-year option):
    - Students are assigned a supervisor from RUC in late September 2025
    - Defense of thesis proposal at RUC in mid-March 2026
    - Defense of final thesis at RUC in late June or mid-September 2026
    - Defense of the thesis at Luiss in October / November 2026
  - Option B (two-year option):
    - Students are assigned a supervisor from RUC in June 2026
    - Defense of thesis proposal at RUC in late November 2026
    - Defense of the thesis at Luiss in April 2027
    - Defense of final thesis at RUC in early May 2027
- IMPORTANT: According to RUC policy, students choosing the one-year option (A) must defend their thesis onsite; and online defense is not possible. Students choosing the two-year option (B)

might be able to defend their thesis online, but this is not guaranteed and would require a specific approval from the authorities of RUC.

• Students are reminded that they are required to comply with the Luiss regular procedure regarding the thesis assignment, registration for the degree exam and upload of the thesis. For further information, please check the <u>following page</u>.
