- Students participating in this program may not be able to graduate at Luiss in July 2026 but will be able to do so in October/November 2026, provided they pass all exams.
- Students who, due to exceptional circumstances, need to graduate in Summer 2026 may apply for an early grading procedure at BI. This procedure is entirely managed by BI and is initiated at the student's request. The availability of this option is subject to BI's internal regulations.
- It is not possible to request an official renounce of grade registration.
